

# Marion County Fair's Talent Competition



You are applying for the Marion County Fair's "Talent Competition" (MCF-CT) a program managed again this year by the Teen Idol program and produced by Dark Wing Productions. All participants need to register to compete online. This formal application must be completed by each contestant and turned in on the day of your performance. Each member of the act must complete an application. **The in person contest will be held on July 15<sup>th</sup>, 2018.**

Residency Requirements: Contestant must be a US citizen and permanent resident of the State of Oregon for the last 6 months. Age Requirements **by Sept 1<sup>st</sup>, 2018** must be: Child: 5 to 9, Youth 10 to 17 or adult: 18+. If there is more than 1 person in an act, the category is based on the oldest person (example 6, 12, 16 & 18 is still in the adult category).

Contestant(s) are responsible for bringing their own music with them on a flash drive, phone or similar device – No CD's. Must also bring props, instruments, support devices etc. Only 4 microphones with stands and plug in capability for several devices / instruments are provided. We can accommodate more microphones. Keyboard and other equipment needed for act must be brought ahead of time. **All entertainment talents are eligible – not only singing. Can be multiple languages as well.**

Winner of each category will receive rewards available through the Marion County Fair website and eligible to compete at the Oregon State Fair Talent Competition in the same division they won at the Marion County Fair. 2<sup>nd</sup> and 3<sup>rd</sup> place: Contestants will receive prizes as noted on the MCF site. Non-Professionals only. Prior State Fair winners are not eligible to compete.

Teen Idol: Contestants residing in the Portland metro area will be entered in to the Teen Idol program for the 2019 Season 13 consideration. It's free and there's no obligation. You will be required to fill out a Teen Idol application if you decide to compete at that time. Teen Idol Finalists from any year and immediate family members of our management team, due to potential conflict of interest, are not eligible to compete.

Deadline: Online registrations open until July 13<sup>th</sup>, 2018 on a first come, first served basis with no more than 15 acts in each category unless space permits the day of. **DROP IN APPLICATIONS ONLY PERMITTED IF you arrive on time, ready to go and space allows.** If we're full online, you can still come the day of and if there are drops, you may be able to compete.
